



### Help with childcare costs: Universal Credit for childcare



This easy read document tells you about Universal Credit for childcare.

#### What is Universal Credit for childcare?



If you get Universal Credit you can claim back up to 85 per cent of childcare costs for children under 17. The most you can claim is £1,014.63 for one child or £1,739.37 for two or more children.



Parents who get Universal Credit are also able to get more help with childcare costs when moving into paid work or increasing their working hours.



Your Universal Credit work coach can give you more information about this.

#### Can I get the funding?



To be eligible, you – and your partner if you have one – must be:



• Working or about to start work.



Paying childcare costs.



· Getting Universal Credit.



You can't get Universal Credit at the same time as "Tax-Free Childcare".

If you do not get Universal Credit, you can apply online.





If you already have a Universal Credit account, you can <u>sign in to your account</u> to ask about childcare funding.



You can use the money to pay for more than one provider, but they must be a **registered childcare provider**.





**Registered childcare providers** include registered childminders, nurseries, nannies, after school clubs, playschemes and schools.
