# Welcome to Nottinghamshire's admissions to schools: Guide for parents



**This guide contains a wide range of information and advice to help you understand when and how to apply for a school place for your child for September 2025.**

We continue to build on the past successes of Nottinghamshire's schools in raising attainment and increasing progress for all our pupils. We are determined to ensure that all our children and young people really do have the opportunity to fulfil their potential, whatever their background. We work in partnership with schools, children, young people, and their families to help achieve this and we are keen to work with you to ensure that your child's education is a positive and enriching experience.

We encourage families to visit our website, where they can find lots of information about the admission process and strongly recommend that you:

- Refer carefully to the admission oversubscription criteria for your preferred school(s) – this will help you understand how places will be allocated
- Apply on time
- Use all four preferences
- Ensure you include preferences for schools where your child will have a high priority within the admission oversubscription criteria
- Consider how your child will get to and from your preferred school(s) and whether you would be eligible for travel assistance

Almost all children secured a place at one of their nominated schools as a result of the investment in school expansions and new schools in areas of the County where they are most needed. The Council is committed to planning for enough school places and continues to work with our secondary schools to plan for the increased demand.

Most parents who applied on time last year were offered a place for their child at one of their preferred schools (over 99% at primary phase and over 98% at secondary phase). We are proud that we are still able to meet families' preferences even with growing pupil numbers in the secondary phase.

Demand for secondary school places is high and it is so important that families review the information in this guide carefully. It cannot be stressed strongly enough that by listing only one or two preferences, parents may substantially reduce the chances of getting their child into their preferred school, or indeed a nearby school.

Last year, an average of 30% of all on-time applications for 2024 from Nottinghamshire parents listed only one preference. If you apply late or list one preference you may substantially reduce the chances of your child being able to attend a school close to your home address.

Remember to check the key dates in this guide, we cannot stress strongly enough the importance of applying on time and listing four preferences.

# Frequently asked questions



## How will I know when to apply?

The county council makes every effort to issue information on applying for a school place to all known families living in Nottinghamshire. Information about key dates is available on our website and on page 8. It is your responsibility, as a parent, to apply for a school place and make sure that your application is submitted on time.



## How do I know where to apply?

You can check your home local authority at [www.gov.uk/find-local-council](http://www.gov.uk/find-local-council). If you do not live in Nottinghamshire, you must apply to your home local authority. Contact details for neighbouring local authorities are available on page 38.



## My child has an education, health and care plan (EHCP), do I still need to apply?

If your child has an education, health and care plan (EHCP), different arrangements apply and you should contact the Integrated Children's Disability Service (**0115 804 1275**).



## Do I still need to apply if my child attends a nursery?

**Yes.** Your child will not automatically transfer from nursery to school. You must still submit an application on time for a school place and we recommend you list four preferences.



## Will my child automatically transfer from infant to junior or from primary to secondary school?

**No.** You must still submit an application on time for a school place and we recommend you list four preferences. You should refer to the criteria for your preferred schools to see if attending a linked school gives you any priority, information is available at [www.nottinghamshire.gov.uk/admissions](http://www.nottinghamshire.gov.uk/admissions)



## My child stays with other relatives during the week. Which address should I use on my application?

The address you give on your application must be the one at which your child permanently lives on the closing date for applications.



## How can I find out if I live in a school's catchment area?

You can view the catchment for Nottinghamshire schools or check which catchment serves your home address by visiting [www.nottinghamshire.gov.uk](http://www.nottinghamshire.gov.uk). Nottinghamshire County Council cannot guarantee that information obtained from other third-party sources will be accurate.

### The school I want to apply for is outside of Nottinghamshire, where do I apply?

Nottinghamshire residents can make up to four school preferences in order of priority on a single application. You must still apply to Nottinghamshire County Council if you live in Nottinghamshire even if you are applying for schools in other local authority areas. All local authorities are required to coordinate admissions for primary (including infant and junior) and secondary schools (including schools with an atypical age range) in their area.

### I have completed a supplementary information form. Do I need to do anything else?

**Yes.** You must still submit an application to your home local authority.

### Do I need to tell you about any brothers or sisters attending my preferred schools?

**Yes.** It is important that you tell us about any brothers or sisters attending your preferred schools or the linked school as this may give your child higher priority in the oversubscription criteria.

### Do I have to list four preferences?

We recommend that you list four preferences on your application. If you only list one preference you substantially reduce the chances of your child being allocated a preference or a nearby school.

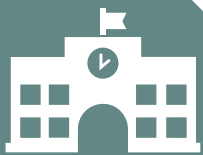
### How are applications considered?

All applications are considered using the admission oversubscription criteria for your preferred school. These can differ between schools, and you should read the determined admission arrangements for the school to see how your application would be considered, information can be found at [www.nottinghamshire.gov.uk/admissions](http://www.nottinghamshire.gov.uk/admissions) On-time applicants who apply online or provide an email address will receive the outcome to their application on National Offer Day. For all other on-time applicants, outcomes will be sent by letter posted second class on National Offer Day.

### Will I automatically be allocated my catchment school if you cannot meet my preference?

**No.** If you do not list your catchment school on your application and that school is oversubscribed with preferences, you will be allocated the next closest school with places available. This may be some distance from your home address.





# School admissions

If you live in Nottinghamshire and require a school place for your child in September 2025, you must apply through Nottinghamshire County Council.

Applications for school places at all other times (known as in-year applications) are dealt with differently. Please see [www.nottinghamshire.gov.uk](http://www.nottinghamshire.gov.uk) for information on how in-year applications can be made and how they will be processed.

The county council, as the admission authority for community and voluntary controlled schools, is responsible for setting and applying schools' admission arrangements.

For foundation and voluntary aided schools, including trust schools, the admission authority is the governing body of the school. For academies, the academy trust is the admission authority. All admission authorities, including free schools and studio schools, must comply with the requirements of the School Admissions Code and admissions legislation. Information about the admission oversubscription criteria for all schools is available at [www.nottinghamshire.gov.uk/admissions](http://www.nottinghamshire.gov.uk/admissions)



For information about all Nottinghamshire schools, including a summary of the oversubscription criteria and how places were allocated last year, we recommend that you look at **Admissions to schools: school information 2025-2026** to help you decide which four schools to apply for. This information is available online. See page 8 for more important dates to remember. It is important that you submit your application before the closing date.

## Applying online

**If you are a Nottinghamshire resident and require a school place for your child in September 2025, the best way to apply is online at [www.nottinghamshire.gov.uk/admissions](http://www.nottinghamshire.gov.uk/admissions)**



- The person making the application must hold parental responsibility
- You will need an email address to register
- Once you have completed your online application, remember to submit it
- If you make any changes to your application, you must also resubmit otherwise it will not be processed correctly
- You will be sent an email confirming that we have received your preferences
- You can attach supporting information for each of your preferences
- On-time applicants will receive an email with their outcome on National Offer Day
- On-time applicants will be able to view their outcome online on National Offer Day
- If you make an account and forget your password, you can request a password reset online



**If you do not apply online you must still complete an application before the closing date.  
If you do not provide us with an email address your outcome will be posted second class on National Offer Day.**

## Other ways to apply

- Contact our customer service team to make an application over the telephone or to request an application form.
- Download an application form from [www.nottinghamshire.gov.uk/admissions](http://www.nottinghamshire.gov.uk/admissions) and return to the school admissions team.

## Multiple applications

In cases where multiple applications are received for the same child, Nottinghamshire County Council will establish where the child lives for the majority of the time. If the child lives with both parents on an equal basis, the parents must confirm which address is to be used for the purposes of allocating a school place. If agreement is not reached the address held by the child's current provision will be used.

If two different applications are received for the same child containing different preferences or different order of preference, parents will be required to submit a joint application or provide court documentation to evidence the preferences that should be used for the admission process. Until an agreement is reached neither application will be processed. If those with parental responsibility are unable to agree on the preference and/or order of preference received by Nottinghamshire County Council, it may be necessary for parents to obtain further legal advice.

If parents are in the process of obtaining legal documentation, Nottinghamshire County Council must receive a copy of the final order by the exceptional late date, listed on page 8.



# Home address

The address you give on your application must be the one at which your child is permanently living at the time of application. Addresses of other relatives or friends will not be considered as the place of residence, even if your child stays there for all or part of the week. This address may need to be verified and we may ask you for proof.

## Change of address

If you move house after you have submitted your application, it may affect how your application is considered against the school's admission oversubscription criteria.

If your address changes after the dates given on page 8, we will not be able to process the application from the new address. The address given on the original application will be used for the purpose of allocating a school place as the application information will have already been exchanged with other local authorities and own admission authority schools.



**If you move to a new address after the closing date and before the last date for exceptional late applications, you may be asked to provide evidence of your new address. Failure to provide this evidence may affect how your application is processed.**

### Examples of the types of evidence that we will accept include:

- All pages of child tax credit award notice for the current financial year.
- Medical letter or prescription that is no more than 3 months old.
- Tenancy agreement.
- Current financial year's council tax letter or statement.
- Bank statement, no more than 3 months old.
- Driving licence.
- Utility bill, no more than three months old.

It is your responsibility to let us know when you move house. It is important that we receive this information as soon as possible so that your application can be processed correctly.

## What if I move to another local authority?

All applications must be made to your child's home local authority. If you move out of that local authority area before the closing date it is your responsibility to reapply to your new home local authority. If you move after the closing date, you must inform the local authority of your move so that your application can be transferred to the new home local authority. Your new home local authority will be responsible for communicating the outcome to your application.



## Children of UK service personnel and crown servants

Nottinghamshire County Council will use the address at which the child will live when applying the admission oversubscription criteria, as long as the parent provides some evidence of their intended address. A unit or quartering address is used as the child's home address where a parent requests this and evidence, such as an official letter declaring the relocation, is received. This must be provided at the time of application.

Overseas nationals entering the UK, who wish to apply for a state-funded school place, are advised to check that they have a right of abode ([www.gov.uk/right-of-abode](http://www.gov.uk/right-of-abode)) or that the conditions of their immigration status otherwise permit access to a state-funded school.

## Fraudulent or misleading information

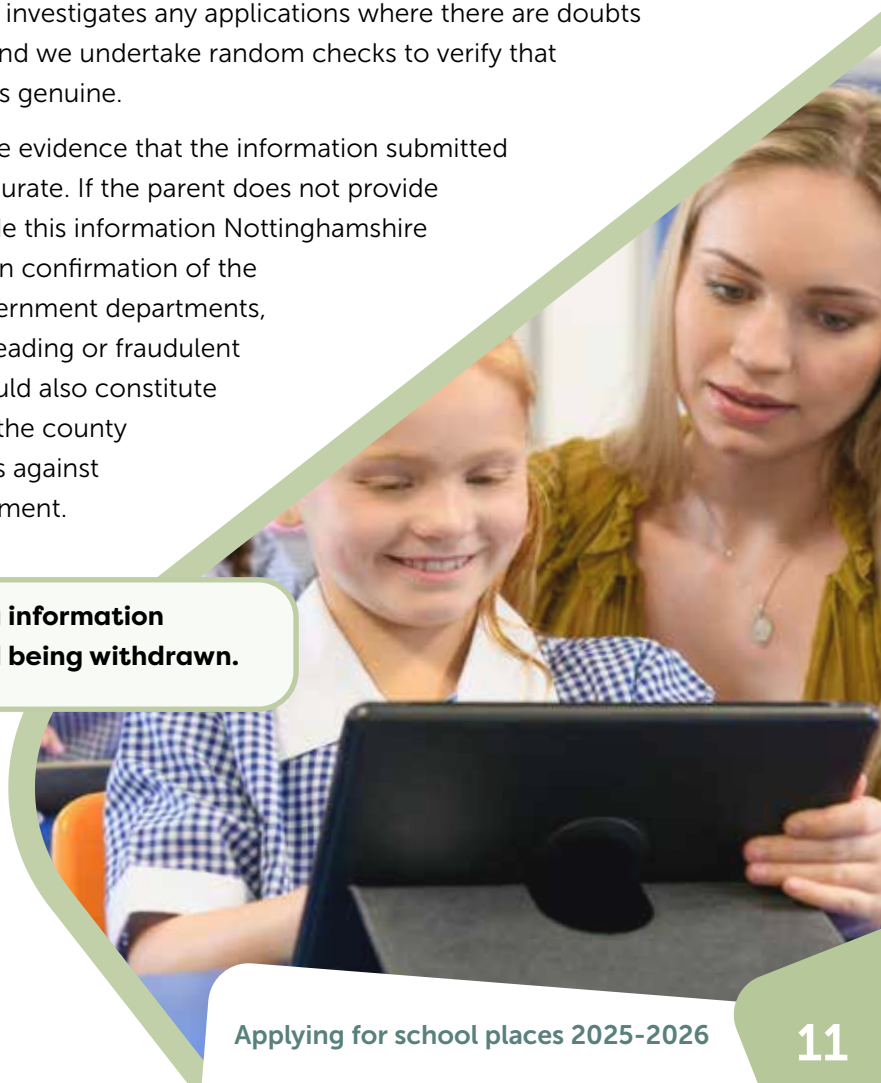
Each year a few parents use false information on their application to try to increase their chance of getting a place at their preferred school.

Nottinghamshire County Council investigates any applications where there are doubts about the information provided and we undertake random checks to verify that information provided by parents is genuine.

Parents will be required to provide evidence that the information submitted as part of the application was accurate. If the parent does not provide information or is unable to provide this information Nottinghamshire County Council will seek to obtain confirmation of the information from other local government departments, including schools. Providing misleading or fraudulent information on an application could also constitute an offence which might result in the county council starting legal proceedings against the person providing a false statement.



**Using fraudulent or misleading information may result in the place offered being withdrawn.**





# Listing your preferences

**Before submitting your application, it is important that you have carefully considered the schools you would like your child to go to and have read the oversubscription criteria which will help you understand how places will be allocated.**

We recommend that you use all four preferences as listing only one preference could substantially reduce the chances of your child being allocated a preference. We also recommend that at least one of the preferences on your application should be for a school where you are sure that your child will meet one of the higher criteria for admission. Once you have decided which four schools to apply for, you need to list them in order starting with the one you would most like your child to attend. Your preference order is very important.

**When listing your four preferences, it is important that you:**

- Tell us if your child is looked after by a local authority or was previously looked after. You should also tell us the name of the local authority.
- Check the oversubscription criteria for your preferred schools.
- List the schools in order starting with the one you would most like your child to attend. Remember check the school's name carefully as some schools have similar names. It is your responsibility to make sure the application is completed correctly.
- Give us details of any brothers and/or sisters (including their date of birth) who will be attending your preferred schools in September 2025. It is important that you also tell us if any brothers and/or sisters are attending the linked school.
- Check whether you also need to complete a supplementary form or provide additional information.
- Remember that the address you give on your application must be the one at which your child is permanently living. If you are moving address, it is important that you inform us of the address you and your family will be moving to on your application to ensure that your application is processed correctly.
- Consider how your child will get to and from your preferred school(s) and whether you would be eligible for travel assistance.

Remember that living in the catchment area, attending a nursery or children's centre, attending a linked school or having a brother or sister attending a school does not guarantee that your application will be successful. For some admission authorities it may give your application higher priority within the admission oversubscription criteria.



## Supporting information

Some schools require additional information such as a letter from a minister, in order to apply their admission oversubscription criteria. Please check the admission oversubscription criteria, available at [www.nottinghamshire.gov.uk](http://www.nottinghamshire.gov.uk) to see whether you need to complete a supplementary form or provide additional information. You must remember to send any supporting information to the correct admission authority by the closing date.

If your child has a physical disability that affects their mobility you should speak to the headteacher of the school you prefer before making any final decisions. Alternatively, you can contact the Integrated Children's Disability Service for further advice (**0115 804 1275**).



**Ensure that you list four preferences, submit your application and any supporting information before the closing date.**





# How are applications processed?

All schools have a published admission number (PAN). This is the number of school places that must be offered in each relevant age group in a school.

## Coordinating admission applications

All schools must have admission oversubscription criteria, this is used if there are more applications than places available. If a school is not oversubscribed all applicants must be offered a place. The admission oversubscription criteria determine how places are allocated at the school: the first criterion represents the group of children most likely to get a place at the school; the last criterion represents the group of children least likely to get a place.

Nottinghamshire County Council is the admission authority for Nottinghamshire community and voluntary controlled schools and will allocate places based on the admission oversubscription criteria for the school. Academies set their own admission oversubscription criteria and information can be found on the school website.

Information about the admission oversubscription criteria for all Nottinghamshire schools is available online at [www.nottinghamshire.gov.uk/admissions](http://www.nottinghamshire.gov.uk/admissions)

All schools in Nottinghamshire are required to coordinate their applications with the local authority for first admission (reception), transfer from infant to junior/primary (year 3) and primary to secondary (year 7). Information about each preference will be shared with admission authorities for consideration against their admission oversubscription criteria for the school. We also send applications to other local authorities if preferences are received for schools in their area.

Preferences are considered against the individual school's admission oversubscription criteria and schools are not told the order of preferences. When a place can be offered at more than one of the schools listed on an application, we will offer a place at the highest preferred school where a place is available. This is for all preferences whether they are for academy, community, foundation, free, trust, voluntary aided or voluntary controlled schools. When any preference is offered, lower preferences will be withdrawn through the coordinated scheme.

The full details of Nottinghamshire County Council's coordinated admission scheme can be found at [www.nottinghamshire.gov.uk/admissions](http://www.nottinghamshire.gov.uk/admissions)

All Nottinghamshire community and voluntary controlled schools have a catchment area which forms part of the admission oversubscription criteria. You can view the catchment area for those schools at [www.nottinghamshire.gov.uk](http://www.nottinghamshire.gov.uk) Remember to check the admission oversubscription criteria for own admission authority schools as not all schools have a catchment area.

## Special consideration for community and voluntary controlled schools

Within each set of criteria, Nottinghamshire County Council will consider applications for community and voluntary controlled schools where the application can be supported by written evidence from a doctor, social worker or other relevant professional stating why a particular school is the only school which could cater for the child's particular needs. The evidence must be presented at the time of application.

- For information provided before the closing date for intake applications, the appropriate designated officers will consider each case and decide the allocation of any such place on the basis of written evidence. Where it is agreed that a particular school is the only school that could meet a child's needs, the application will have priority following the allocation of looked after and previously looked after children.
- For information provided after the closing date, the appropriate designated officers will consider each case. If it is agreed that a particular school is the only school that could meet a child's needs, the application will have priority after looked after and previously looked after children. If the school is oversubscribed the application will have priority on the waiting list after the initial allocation of places.

### **Where a request for special consideration is not approved:**

- For information provided before the closing date for intake applications, a decision on the request for special consideration will not be communicated. The application will be considered in line with the published admission oversubscription criteria and an outcome issued alongside all other applications on National Offer Day.
- For information provided after the closing date, a decision based on the evidence provided will be communicated to the applicant.



## Example of how the coordinated scheme works

Robin lives in the **catchment** area of a popular school, The Green School. Robin has a **brother** attending The Blue Academy and Robin currently attends The Rainbow Voluntary Aided School (VA) which is a school **linked** to The Red VA School. Robin's parent submitted the following preferences online before the closing date.

Rank	Preference	Criteria summary	Places available	Application outcome	Waiting list
1	The Blue Academy	Lives out of catchment area	No	No	Yes
2	The Red VA School	Attends linked school	Yes	Yes	N/A
3	The Green School	Catchment school	Yes	No	N/A

### Preference 1

There are not enough places at The Blue Academy for all the children who have applied. The Blue Academy was only able to offer places to pupils living in the catchment area.

### Preference 2

There are not enough places at The Red Voluntary Aided School for all the children who have applied. The Red Voluntary Aided School was only able to offer places to pupils attending the linked school.

### Preference 3

There are enough places at The Green School for all the children who have applied.

### Preference 4

There are not enough places at The Orange School for all the children who have applied. The Orange School was only able to offer places for pupils living in the catchment area and who have a brother or sister attending the school.

Places could be offered at both The Red VA School and The Green School. The local authority communicates the decision to offer a place at The Red VA School as Robin's parent ranked this school higher than The Green School. Robin is then placed on the waiting list for The Blue Academy and offered the right of appeal.





# Outcome of your application

## When will I receive the outcome to my application?

- For on-time applicants who applied online or provided an email address, you will be sent an email on National Offer Day.
- All other on-time applicants will be notified by letter posted second class on National Offer Day.



**No outcomes can be given over the telephone. The application can only be discussed with the applicant or named contact.**

## Do I need to accept an offer of a place?

You will be asked whether you wish to accept the place offered. We recommend that you always accept the offer of a school place, this will not affect your right of appeal for a place at any school where you have been refused.



**Some admission authorities may withdraw the offered place if a parent fails to inform the county council of their acceptance of the offer within 14 days.**

## What if all my preferred schools are oversubscribed?

Most children are offered a place at one of their preferred schools. If your child is refused a place at your preferred school(s) you have a right to appeal.

If it is not possible to offer any of your preferences and your child is without a school place, the county council may make an 'alternative offer' of a school place that is further away from your home address.

Parents sometimes think that making only one preference will ensure that a place is allocated at that school, but that is not the case and children are not automatically offered a place at their catchment area school. If there is no place available at your preferred school(s), an alternative offer will be made at the nearest school with places available after all on-time preferences have been considered. If all places at other schools close to your child's home address have been allocated, the alternative offer may be for a school which is a distance away. In the event of schools becoming oversubscribed through this process, places are allocated to those living closest to the school by walking distance. An alternative offer reduces the likelihood of any child being left without a school place and does not affect your right to appeal for a place at any school where you have been refused.

## Waiting lists

Your preference order is important as children's names are only placed on a waiting list for any school that the parent has ranked higher than the school that has been allocated. If a place is subsequently allocated the child's name will be removed from the waiting list for any lower preferences.

Priority on the waiting list will be decided by reference to the admission oversubscription criteria and not by the date an application was received.

All admission authorities must maintain a waiting list until at least 31 December. All Nottinghamshire community and voluntary controlled schools maintain a waiting list until 31 May. Being on a waiting list does not mean that a place will eventually become available.

Your position on a waiting list may change. If any late applications have a higher priority within the admission oversubscription criteria, they will be placed higher than applications that have been on the list for some time.

If the number of allocated places falls below the published admission number for the school, the county council will write to offer a place to the applicant at the top of the waiting list.

## School admission appeals

When an application for a school is refused, the parent has a right to appeal to an independent appeal panel. You will be informed of this when you receive your outcome. Further information about appeals for community and voluntary controlled schools is available at [www.nottinghamshire.gov.uk](http://www.nottinghamshire.gov.uk). For all other schools you should contact the school directly for information on how to appeal.

## Infant class size appeals

Infant classes must not contain more than 30 pupils with a single school teacher. When an infant class has already reached the legal limit of 30, appeal panels can only offer a place in very limited circumstances.

## Infant class size

The law limits the size of an infant class (a class in which the majority of children will reach the age of 5, 6 and 7 during the school year) to 30 pupils per school teacher.

The class size legislation makes allowance for the entry of an additional child in certain limited circumstances. The School Admissions Code 2021 (section 2.16) sets out these exceptions.

A child who falls into one of these categories will not automatically be admitted as an excepted child.



# Late applications and changes to preference(s)

Any applications received after the closing date, including changes to preference, are considered as late applications and will be processed after all on-time applications.

Submitting your application late increases the risk of not getting a place at one of your preferred schools as places will have been allocated, on National Offer Day, to people who applied on time. If the school you prefer is oversubscribed, your child is more likely to have to travel further to the nearest school with places available and you may be responsible for transport costs.

In **very limited circumstances**, applications received after the closing date and before the exceptional late date may be considered by Nottinghamshire County Council (in agreement with the relevant admission authority) as on time if the application meets one of the following:

- Relocation into the area of Nottinghamshire County Council from another local authority area
- Relocation within Nottinghamshire
- Exceptional reasons for missing the closing date, for example family bereavement, hospitalisation or family trauma



## Key dates

Information outlining why the application was late, together with evidence of any relocation must be provided at the point of application. In order to consider whether the application can be processed as on time, information must be received by:

- **Monday 25 November 2024** for children transferring from primary phase to secondary education and for applications to a school with an atypical age.
- **Friday 31 January 2025** for children starting school for the first time and children transferring from infant to junior/primary education.



**Any application or supporting information received after these dates will be considered late and will not be processed until after National Offer Day. The first late processes are:**

- **Tuesday 18 March 2025** for children transferring from primary phase to secondary education and for applications to a school with an atypical age.
- **Wednesday 30 April 2025** for children starting school for the first time and children transferring from infant to junior/primary education.



**A maximum of four preferences can be processed as late on an application at any one time and you must wait for the outcome of these preferences before making further changes.**

Any applications or changes to preference received after the first date process will be processed on a weekly basis.

Where it has not been possible to meet a parental preference on an application and the child is without a school place, your child may be allocated an alternative offer. Information can be found on page 17.

## Repeat applications

If your application for a Nottinghamshire community or voluntary controlled school has been refused, you will not be given a further right of appeal for the same school in the same school year unless the admission authority considers there have been significant and material changes in your circumstances, or those of the school.

# Admission outside of the normal age group

## When does my child start in reception?

All children can start school full-time in reception in the September following their fourth birthday. However, parents can request that the date their child is admitted to school is deferred until later in the academic year 2025-2026, or until the term in which the child reaches compulsory school age within this year.

Parents can also request that their child takes up the place part-time until the child reaches compulsory school age within the 2025-2026 school year. Parents must ensure that they apply for a school place before the closing date (15 January 2025) if they want their child to start in the reception class.

## Summer born children

Most children start school in the September after their fourth birthday, but some children will benefit from a delayed school start, particularly if their school readiness has been delayed by a medical condition or developmental delays. The parents of a summer born child (born between 1 April and 31 August) may choose not to send that child to school until the September following their fifth birthday.

The admission authority decides whether children who start school at compulsory school age should be admitted to reception or year 1. They must make this decision in the child's best interests. If the request is refused, the parent must decide whether to apply for a place in the normal age group, or to make an in-year application for admission to year 1 for the September following the child's fifth birthday.

## Requesting admission outside of the normal age group

Parents may seek a place for their child outside the normal age group, for example, if the child is gifted and talented, or has experienced ill health or is a summer born child wishing to start school in reception instead of year 1. This is not limited to applications for those starting school for the first time but includes children moving from infant to junior/primary schools and primary to secondary schools.

Nottinghamshire residents should submit a request to the admission authority as early as possible. The admission authority will make decisions based on the circumstances of each case and in the best interests of the child concerned. This will include taking account of the parent's views; information about the child's academic, social and emotional development; where relevant, the child's medical history and the views of a medical professional; whether they have previously been educated out of their normal age group; and whether they may naturally have fallen into a lower age group. The views of the headteacher of the school concerned will also be taken into account. When informing a parent of the decision on the year group to which the child should be admitted, the parent will be notified of the reasons for the decision.

Where it is agreed that a child will be admitted out of the normal age group and, as a consequence of that decision, the child will be admitted to a relevant age group (that is, the age group to which pupils are normally admitted to the school) the local authority and admission authority must process the application as part of the main admissions round on the basis of their determined admission arrangements only, including the application of admission oversubscription criteria where applicable. The parent has a statutory right to appeal against the refusal of a place at a school for which they have applied. This right does not apply if they are offered a place at the school but it is not in their preferred age group. ## Transfer to infant to junior and primary to secondary school

Where a child has been educated out of the normal age group it is the parent's responsibility to request admission out of the normal age group again when they transfer from infant to junior or primary to secondary school. It will be for the admission authority of the preferred school to decide whether to admit the child out of the normal age group. The admission authority must make a decision on the basis of the circumstances of each case and in the child's best interests, and will need to bear in mind the age group the child has been educated in up to that point.

## Home to school travel assistance

The County Council's strategy encourages the use of sustainable travel modes to get to school. Sustainable travel means walking, scooting, cycling, car-sharing and the use of public transport. Schools are encouraged to develop and maintain a travel plan for their school promoting and encouraging sustainable methods of travel in order to reduce congestion around school, increase the safety of children on the school journey and promote a healthier way to get to school.

## Travel assistance

Assistance with home to school travel will not be a requirement for most children as they will attend their local school which is within a reasonable walking distance accompanied by a parent/carer as necessary.

You should consider carefully how your child will get to and from your preferred schools before you make your application for a school place.

Children will only be eligible for free travel if they have an entitlement under the County Council's Home to School Transport Policy. It is important that, when selecting your preferences for school admission, that you have read and understood the information available to you regarding school admissions and travel assistance.

If your child is eligible for free travel assistance, they will be provided with a travel pass for either a school bus service or public transport. If neither of these is available, we may provide you with parental mileage for you to make your own travel arrangements.

If your child is not eligible for free travel assistance but you would like your child to travel to school by bus, you may be able to buy a season travel pass from us.

## Special transport needs

Some pupils with Special Educational Needs or Disabilities (SEND) may be entitled to special transport arrangements. Wherever possible and appropriate, pupils with SEND should be treated in the same way as those without - that is, in general, they should walk to school, travel on public transport or be taken by their parents/carers.

### **A special transport need may arise where your child:**

- lives within the walking distance but cannot walk/travel safely to school even if accompanied by a parent/carer
- is unable to use public transport when accompanied by a parent/carer.

**It is your responsibility to arrange to get your child to school and to apply for travel assistance if you think you are eligible.**



## Special educational needs and disability

The EHC Assessment Team is responsible for placing children with an education, health and care (EHC) plan.

The EHC Assessment Team has prepared specific guidance for the parents and carers of children and young people with an EHC plan. A copy of this will be sent to those parents in **August 2025** if your child is due to have a key stage transfer in the 2025-2026 academic year. The guide which explains the process and timelines for key stage transfers is also available online [www.nottshelpyourself.org.uk](http://www.nottshelpyourself.org.uk)

If your child has an EHC plan your application for a school place will be processed by the Integrated Children's Disability Service's EHC assessment team as different arrangements apply. They are responsible for identifying schools and placing children with an EHCP, if you have any queries you should contact them on **0115 804 1275**.

### What if my child has special education needs (SEN) but does not have an EHC plan?

Nottinghamshire's SEN and Inclusion Strategy (available at [www.nottinghamshire.gov.uk](http://www.nottinghamshire.gov.uk)) describes the way in which support is provided for children with SEN in mainstream schools. Each individual school will also describe the arrangements that it makes to support pupils with special educational needs in its SEN policy. The SEN policy should be available electronically on the school's website, to be downloaded and/or in hard copy from the school on request.

If your child does not have an EHC plan then their school placement will be co-ordinated under the same arrangement as children who do not have special educational needs. **You should submit an application in the normal admissions round by the closing date** listing four preferences (mainstream schools only) and the application will be processed by the school admissions team, the outcome of a child, young person (CYP) going through the EHC needs assessment process does not automatically mean they will be issued with a statutory EHC plan, and it is only following the decision to issue a plan that the EHC assessment team will take responsibility for placing a CYP in an education setting.

If your child is awarded an EHC plan after the application has been processed, the allocated school will be reviewed by the ICDS team and in some cases, the school offered may be named on the EHCP.

## What if my child has a physical disability that affects their mobility?

Some schools require adaptations in order to enable pupils with a physical disability to access teaching environments. Not all schools currently have suitable access and there are some schools where it may not be possible to provide full access for pupils who use a wheelchair or have other specific needs. The county council is adapting as many mainstream schools as possible.

The schools with a wheelchair symbol, in Admissions to schools: School information 2025-2026, have told us that they are at least 75% accessible to children in wheelchairs. You should, however, always visit a school to check that arrangements are suitable for your child.

School premises are constantly being adapted so it may be wise to speak to the headteacher or the Special Educational Needs Coordinator (SENCO) of the school you are considering before you make any final decisions. Details about a school's accessibility should be set out in the school's SEN policy (or may be a separate plan linked to the SEN policy).

Your child's mobility difficulties may mean that the catchment school is not suitable. If this is the case and your circumstances meet the criteria within the Home to School Transport Policy, your child may be entitled to transport support. If necessary, we will provide free home to school transport or travel assistance to the school we think is the nearest suitable school.

## Vaccination (immunisation)

Vaccination is the most effective way of keeping children protected against infectious diseases. Vaccines are available free on the NHS for all eligible children and more information can be found on the NHS website <https://www.nhs.uk/conditions/vaccinations/childhood-vaccines-timeline>

If you are unsure whether your child is up to date with their immunisations, please check their red book or contact their GP practice for advice. The school aged immunisation service (SAIS) will visit schools annually to administer the flu vaccine to those children who are eligible through the NHS. They will also administer the HPV vaccination (to help protect against some cancers) in year 8 and visit in year 9 for the Meningitis vaccinations and Diphtheria, Tetanus and Polio (DTaP) booster. Measles is currently circulating in this area. Any young person that has missed out on one or both Measles Mumps and Rubella (MMR) vaccinations can also have this in year 8 or 9 or via their GP at any time. Parents will be contacted with information and asked for consent before their visit.

Please make sure that your child's vaccinations are up to date to protect them, their families and the NHS.

## Become a school governor

A number of schools across Nottinghamshire are in need of volunteer governors to join their governing bodies. School governors are critical to the effective running of schools. This is an excellent opportunity for you to make an enormous difference to children in your local community.

# Extra support for families

## Universal infant school meals

There is a statutory requirement for state-funded schools in England to provide free school meals to all pupils in reception, year 1 and year 2.

## Free school meals

We want to make sure as many eligible pupils as possible are claiming their free school meals. We use the Department for Education's free school meals eligibility checking system to determine eligibility where possible. In some cases we will need to ask for additional documentation to help us assess your claim manually.

## Free school milk

The eligibility criteria for free milk entitlement is exactly the same as for free school meals. Where LAs or schools provide milk, it must be free to children whose parents are in receipt of the same support payments as for benefits-related free school meals.

## Benefits-related free school meals

Free school meals are available to pupils in receipt of, or whose parents are in receipt of, one or more of the qualifying benefits:

- Universal Credit (provided you have an annual net earned income of no more than £7,400, as assessed by earnings from up to three of your most recent assessment periods)
- Income Support
- Income-based Jobseeker's Allowance (JSA)
- Income-related Employment and Support Allowance (ESA)
- Support under Part VI of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit
- Child Tax Credit (with no Working Tax Credit) with an annual gross income of no more than £16,190
- Working Tax Credit run-on (paid for the four weeks after the person stops qualifying for Working Tax Credit).

**In addition, free school meals are available for children in all households with no recourse to public funds (NRPF) subject to a maximum income threshold.**

## Transitional protection

Children eligible for benefits-related free school meals who are transferring between schools that use Nottinghamshire County Council's eligibility assessment service do not need to reapply. Children who are eligible will continue to receive free school meals until the end of transitional protection. After that date, children who are eligible will continue to receive free school meals until the end of their current phase of education (i.e. primary or secondary).

## Additional funding for your child's school

It is important that all parents who receive one of the benefits listed above register for benefits-related free school meals as this will enable the child's school to claim pupil premium allocation. The pupil premium is additional funding given to publicly funded schools in England to raise attainment.

In the 2024-2025 financial year, schools will receive:

- **£1,480** for each eligible primary-aged pupil
- **£1,050** for each eligible secondary-aged pupil.

## We may be able to assist with transport to your allocated school

Children of primary school age from low-income families are entitled to free transport if they live 2 miles or more from their nearest qualifying (catchment area) school.

Children of secondary school age from low-income families are entitled to free transport if the school is between 2 and 6 miles and there are not three or more suitable nearer schools.

Children of primary school age from low-income families are entitled to free home to school travel to the nearest suitable school preferred on grounds of religion or belief, where the school is between 2 and 20 miles from their home address.

Pupils of secondary school age from low-income families attending the nearest suitable school preferred on grounds of religion or belief are eligible for free transport where the school is between 2 and 25 miles from their home.

\*\*distance is measured by using the shortest available walking route

\*\*\*distance is measured using the shortest vehicular route

Low income is defined as being eligible for free school meals (see qualifying criteria) or in receipt of the maximum level of working tax credit.

## School uniform

Each school decides whether to have a school uniform and what items or colours children should wear. You will find details in the school's prospectus or on the school's website. The school will also tell you what games kit your child will need.

No school uniform should be expensive, and schools must make sure the cost of their uniforms is affordable. Schools should make sure that they limit the number of branded items in the uniform and give consideration to recyclable school uniform to benefit the school community and support environmental sustainability.

The county council does not offer financial support to assist parents in purchasing uniform or clothing other than in exceptional circumstances. Exceptional circumstances may mean families who have lost clothes in a fire, a flood, theft, have been made homeless or are fleeing domestic violence. This exceptional payment is in place to support the most vulnerable families and each case is assessed individually. # Specialist support

## The Achievement and Equality team

The team provides guidance to schools around the management of prejudice-based incidents, including those which are based on race, religion, disability, gender reassignment and sexual orientation. ## Elective Home Education

Elective Home Education is considered by some parents as an alternative to sending their child to a school. Any parent wishing to educate their child assumes full responsibility for the education and must ensure that their child receives an efficient full-time education suitable to age, ability and aptitude and to any special educational needs.

Nottinghamshire County Council's Elective Home Education team works in partnership with parents to provide advice, guidance and support and to ensure that children are being suitably educated under the provision of Section 7 of the 1996 Education Act.

## Private foster carers

Private fostering is when you look after a child **under 16 years of age (or 18 if disabled) for 28 days or more** and you are not closely related. There is a legal requirement to notify Nottinghamshire County Council of private fostering arrangements in order to ensure the safety of Nottinghamshire children. # Definitions

**Some admission authorities use definitions that are different from those of Nottinghamshire County Council. It is important, therefore, that you read the admission oversubscription criteria for individual schools carefully.**

Nottinghamshire County Council, as an admissions authority, uses the following definitions for all community and voluntary controlled schools:

## Address

The child's place of residence is taken to be the parental home, other than in the case of children fostered by a local authority, where either the parental address or that of a foster parent(s) may be used. If a child's parents live at separate addresses, the address where the child permanently spends at least three 'school' nights (that is, Sunday, Monday, Tuesday, Wednesday or Thursday) will be taken to be the place of residence. Addresses of other relatives or friends will not be considered as the place of residence, even if the child stays there for all or part of the week. Evidence that the child's place of residence is permanent may also be sought and this should prove that the child lived at the address at the time of the application. Informal arrangements between parents will not be taken into consideration.

## Compulsory school age

A child reaches compulsory school age on the prescribed day following their fifth birthday. The prescribed days are 31 December, 31 March and 31 August. Children must be attending school the term following their fifth birthday. Parents can request that their child takes up the place part-time until the child reaches compulsory school age within the academic year that the place has been allocated for.

## Deferred entry to school

All children can start school full time in reception in the September following their fourth birthday. Parents can request that the date their child is admitted to school is deferred until later in the school year, or until the term in which the child reaches compulsory school age.

## Delayed admission

When a summer born child starts school at compulsory school age (age 5), whether this is in year 1 or reception.



## Linked school

In some instances, attending a particular school gives an application some priority within the admission oversubscription criteria for another named school. This is known as a 'linked school'. Information about linked schools is available in Admissions to schools: School information, available on the County Council's website.

## Looked after and previously looked after children

The School Admissions Code 2021 states that all admission authorities must give highest priority to this group of children and provides the following definition:

A 'looked after child' is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989) at the time of making an application to a school.

Previously looked after children are children who were looked after, but ceased to be so because they were adopted (or became subject to a child arrangements order or special guardianship order). Further references to previously looked after children means such children who were adopted (or subject to child arrangements orders or special guardianship orders) immediately following having been looked after and those children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted.

- A child is regarded as having been in state care outside of England if they were in the care of or were accommodated by a public authority, a religious organisation, or any other provider of care whose sole or main purpose is to benefit society.
- Children who were adopted under the Adoption Act 1976 and children who were adopted under section 46 of the Adoption and Children Act 2002.
- Child arrangements orders are defined in section 8 of the Children Act 1989, as amended by section 12 of the Children and Families Act 2014. Child arrangements orders replace residence orders and any residence order in force prior to 22 April 2014 is deemed to be a child arrangements order. Section 14A of the Children Act 1989 defines a 'special guardianship order' as an order appointing one or more individuals to be a child's special guardian (or special guardians).

## Multiple births (twins, triplets etc)

For community and voluntary controlled schools, where one child of a multiple birth can be admitted through the normal admissions process, the other child/children will also be admitted.

## Parent/parental responsibility

The person making the application must hold parental responsibility. Nottinghamshire County Council considers the parent to be:

- The mother of the child
- The father of the child where he was married to the mother either when the child was born or at a later date
- The father of the child if (since 1 December 2003) he was registered as the father on the birth certificate
- An adoptive parent
- Any other person who has acquired 'parental responsibility' through the courts; evidence of this may be required
- Authorisation may also be given for another person to speak on the parent's behalf.

## Sibling (brother or sister)

Nottinghamshire County Council considers a sibling to be:

- Brothers and/or sisters who share the same parent(s)
- A half-brother, half-sister or legally adopted child living at the same address
- A child looked after by a local authority placed in a foster family with other school age children
- A stepchild or children who are not related but live as a family unit, where parents both live at the same address as the child.

## Displaced sibling

A child is considered to have been displaced if they applied on time for their Nottinghamshire community catchment area school and they were not allocated under the coordinated scheme as the school was oversubscribed with catchment area children at national offer day. If the older sibling was subsequently offered a place at the community catchment school from the waiting list and this offer was declined, the child will not be considered as displaced, and any younger siblings would not be given any additional priority in the admission oversubscription criteria.
