THE NOTTINGHAMSHIRE (RUSHCLIFFE) DEFINITIVE MAP AND STATEMENT

THE NOTTINGHAMSHIRE COUNTY COUNCIL  
(COSTOCK FOOTPATH NOS. 9 AND 10) MODIFICATION ORDER 2025

This Order is made by the Nottinghamshire County Council under Section 53(2)(b) of the Wildlife & Countryside Act 1981 ("the Act") because it appears to that Authority that the Nottinghamshire (Rushcliffe) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in:

Section 53(3)(b) of the Act namely: the expiration, in relation to any way in the area to which the map relates, of any period such that the enjoyment by the public of the way during that period raises a presumption that the way has been dedicated as a public path; and also

Section 53(3)(c)(i) of the Act, namely: the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path.

The Authority have consulted with every Local Authority whose area includes land to which the Order relates. The Nottinghamshire County Council hereby order that:

1. For the purposes of this Order the relevant date is 6<sup>th</sup> October 2025.
2. The Nottinghamshire (Rushcliffe) Definitive map and statement shall be modified as described in Part I and Part II of the Schedule and shown on the plan contained in this order ("the Order Plan").
3. This Order shall take effect on the date it is confirmed and may be cited as "The Nottinghamshire County Council (Costock Footpath Nos. 9 and 10) Modification Order 2025".



Modification of Definitive Map

Description of the Paths or Ways to be added

**Costock Footpath No. 9**

Commences from the junction with Bunny Hill (A60) at SK 5787 2783 (point A on the Order Plan) and proceeds along Ash Lane with no limitations for approximately 900 metres in a generally westerly direction to join Costock Footpath No.6 at SK 5699 2793 (point C on the Order Plan) and with a width of approximately 3 metres.

**Costock Footpath No. 10**

Commences from the junction with Costock Footpath No.9 at SK 5723 2793 (point B on the Order Plan) and proceeds along Ash Lane with no limitations for approximately 85 metres in a northerly direction to the junction with Costock Footpath No.6 at SK 5724 2801 (point D on the Order Plan) and with a width of approximately 2.5 metres.

**A new Statement should be recorded for Costock Footpath 9**

Commences from SK 5787 2783 at the junction with Bunny Hill (A60) and proceeds along Ash Lane in a generally westerly direction on a tarmac surface to SK 5699 2793 to join Costock Footpath No.6.

Approx length: 900m  
Approx Width: 3m  
Limitations: -

**A new Statement should be recorded for Costock Footpath 10**

Commences from SK 5723 2793 at the junction with Costock Footpath 9 and proceeds in a northerly direction along Ash Lane on a tarmac surface to SK 5724 2801 to join Costock Footpath No.6.

Approx length: 85m  
Approx Width: 2.5m
