- 1. The public rights of way over the land situated at South Clifton and Spalford as shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 7 days from the date of confirmation of this Order.
- 2. There shall at the end of 7 days from the date of confirmation of this Order be public footpaths over the land situated at South Clifton and Spalford described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order.

## SCHEDULE

## PART 1

## Description of Site of Existing Path or Way

## South Clifton Footpath No.3

Commencing from a point, SK 8233 6997 at the junction with Coal Yard Lane, South Clifton and proceeding for a distance of approximately 258 metres in a southerly direction and then in a generally south-easterly direction for approximately 200 metres, and then in a generally southerly direction for 90 metres at point SK 8245 6947, at the junction of Spalford Footpath No.8.

## Spalford Footpath No.8

Commencing from the junction with South Clifton Footpath No.3 at point SK 8245 6947 proceeding for a distance of approximately 15 metres in a generally southerly direction to SK 8245 6946 with the remainder of Spalford Footpath No. 8.

## Spalford Footpath No.8

Commencing from the junction with the remainder of Spalford Footpath No. 8 at point SK 8247 6941 proceeding for a distance of approximately 433 metres in generally south-south-west direction to a point, SK 8232 6904, at the junction of Girton Restricted Byway No.1.

# Description of Site of New Path or Way

## South Clifton Footpath No.3

Commencing from a point, SK 8219 6995 at the junction with Coal Yard Lane, South Clifton and proceeding in a generally westerly direction for approximately 13 metres, and then in a generally southerly direction for approximately 270 metres and then proceeding in a generally south easterly direction for a distance of approximately 188 metres, and then proceeding in a generally westerly direction for a distance of approximately 93 metres, and then proceeding in a generally south easterly direction for a distance of approximately 132 metres and then proceeding in a generally easterly direction for a distance of approximately 44 metres and then proceeding in a generally southerly direction for a distance of approximately 12 metres over a bridge, and then proceeding for a distance of approximately 35 metres in a generally easterly direction to the Spalford and South Clifton parish boundary and the junction with Spalford Footpath No. 8 at SK 8242 6946, along a stone and grass surface path and having a width of 4 metres throughout its length.

## Spalford Footpath No.8

Commencing from a point, SK 8242 6946 at the Spalford and South Clifton parish boundary and the junction with South Clifton Footpath No. 3 and proceeding for a distance of approximately 31 metres in a generally easterly direction to a point, SK 8245 6946 at a junction with the remainder of Spalford Footpath No. 8, on a surface of crushed stone and grass, and having a width of 4 metres throughout.

## Spalford Footpath No.8

Commencing from a point SK 8247 6941 at the junction with the remainder of Spalford Footpath No. 8 and then proceeding in a generally southerly direction for a distance of approximately 60 metres to a point SK 8247 6936, and then proceeding for a distance of approximately 240 metres in a south-south-westerly direction to a point SK 8237 6916, and then proceeding in a generally south-south-westerly direction for approximately 100 metres to point SK 8230 6908, then in a generally south-south-easterly direction for a distance of approximately 37 metres to a point, SK 8232 6904, at the Spalford and Girton parish boundary and the junction with Girton Restricted Byway No.1, on a surface of crushed stone and grass, and having a width of 4 metres throughout.
